Notification on the determination of the storage license rates and of the inspection rates for the issuance of a transport permit for transport vehicles and transport vessels and barges concerning various kinds of petroleum and petroleum products

Notification No. 38/2023

1385, 2nd Waning Day of Thadingyut (31 October 2023)

The Ministry of Natural Resources and Environmental Conservation has issued the following notification in exercise of the powers conferred by sections 10 (c) and 54 (b) Petroleum and Petroleum Products Law.

1. The rates specified below shall be charged for issuing a storage license for storage tanks and warehouses that store various kinds of petroleum and petroleum products:

(b)	Renewal fee	1,200	1,500	2,000	2,500	5,000	21,000	10% of the license fee
(c)	Fee for changing the holder	6,000	7,500	10,000	12,500	25,000	105,000	50% of the license fee
(d)	Overdue penalty per day	240	300	400	500	1,000	4,200	2% of the license fee
(e)	Fee for a true copy in case of damage/loss	6,000	7,500	10,000	12,500	25,000	105,000	50% of the license fee

2. The following rates shall be charged as an inspection fee for the issuance of a transport permit for motor vehicles and for vessels and barges that transport various kinds of petroleum and petroleum products:
