Government of the Republic of the Union of Myanmar Ministry of Commerce Intellectual Property Rights Agency Notification No. 2/2023 1385, 2nd Waning Day of Nadaw (29 December 2023)

The Intellectual Property Agency has issued this notification in exercising the powers conferred by section 86(c) Industrial Design Rights Law with the consent of the Ministry of Commerce.

Determining the service fees for applications for industrial design rights registration

1. The fees to be paid for the various types of services regarding applications for industrial design rights registration in accordance with the Industrial Design Rights Law are set as follows according to section 8(i) Industrial Design Rights Law with the consent of the Union Government:

 - (b) The fees specified for requests ID-3, ID-4, ID-6, ID-8, ID-10, ID-16 and ID-18 are for one application only.
- 3. The fees for the various types of services regarding an application for industrial design rights registration will be revised from time to time and made public accordingly.
