Welcome to a new edition of our newsletter.

1. Minimum wage increased

On 9 August 2024, the National Committee for Determining the Minimum Wage under the State Administration Council increased the daily minimum wage as follows starting from 1 August 2024.

Old minimum wage	Daily minimum wage:	MMK 4,800
	Daily allowance:	MMK 1,000
	TOTAL:	MMK 5,800
New minimum wage	Daily minimum wage:	MMK 4,800
	Daily allowance (1):	MMK 1,000
	Daily allowance (2):	MMK 1,000
	TOTAL:	MMK 6,800

The daily allowances are not to be included when calculating overtime rates or rates for work on a weekly rest day or public holiday. The minimum rate for one hour of overtime is therefore MMK $(4,800 / 8) \times 2 = MMK 1,200$ and not MMK $(6,800 / 8) \times 2 = MMK 1,700$.

Announcement of an additional allowance for workers

1. The minimum wage rates, decided according to section 10 (d) Minimum Wage Law 2013 after negotiations with the tripartite representatives as being "4,800 kyats (four thousand eight hundred kyats) for 8 working hours (one day) with a rate of 600 kyats (six hundred kyats) per hour uniformly throughout the country

for workers in Myanmar, regardless of location and type of business" were promulgated with the approval of the Union Government by the National Committee with Notification No. 2/2018 dated 14 May 2018.

- 2. As the minimum wage rate was set at 4,800 kyats for an 8-hour working day, an additional allowance of 1,000 kyats (exactly one thousand kyats) has been offered by Notification No. 2/2023 dated 9 October 2023 since 1 October 2023 on workdays and according to the 1951 Leave and Holidays Act.
- 3. Ministry of Planning and Finance Notification No. 54/2024 dated 26 July 2024 announced for daily staff and daily workers in government departments and organisations: "On top of the currently set wage of 4,800 kyats for an 8-hour working day, an additional allowance of 1,000 kyats has been offered monthly [sic] since October 2023. Now, in addition to the allowance of 1,000 kyats which is currently being provided, 1,000 kyats are to be offered as an additional allowance so that daily workers may enjoy a daily wage of 6,800 kyats (exactly six thousand eight hundred kyats)."
- 4. From 1 August 2024, an additional allowance of 1,000 kyats is to be offered on workdays and according to the 1951 Leave and Holidays Act in addition to the allowance of 1,000 kyats which is currently being provided.
- 5. These particulars shall not apply to small businesses and family-owned businesses with less than 10 workers.
- 6. National Committee for Determining the Minimum Wage Notification No. 2/2023 dated 9 October 2023 is repealed by this notification.
