Welcome to a new edition of our newsletter.

#### 1. Taxes on imports and exports to be paid in MMK at the "market trading rate"

The Ministry of Planning and Finance and the Customs Department under the State Administration Council ("SAC") announced on 27 December 2024 that from 1 January 2025, taxes on imported and exported goods will not be be assessed and collected anymore at the Central Bank reference rate, but at a weekly exchange rate based on the "market trading rate", to be published on the Customs Department's website and Facebook page.

The notification does not state which individual taxes are covered by it, but the import of goods may attract customs duty, commercial tax, specific goods tax, and a 2% advance payment on the importer's income tax. The export of goods is usually tax exempt, with the exception of timber (8% specific goods tax), electricity (8% commercial tax), crude oil (5% commercial tax), and gemstones (5-11% gemstone tax). In addition, exporters must pay 2% of the export value as an advance on their income tax in the currency in which the export is made (section 30 Union Taxation Law 2024).

On 27 December 2024, USD 1 was MMK 2,100 at the Central Bank reference rate and MMK 3,588 at the market trading rate. Shifting tax assessment to the market trading rate is expected to make imported goods more expensive.

- 1. Exercising the powers conferred by section 204 (b) Sea Customs Act, the Ministry of Planning and Finance hereby issues this notification.
- 2. The Customs Department of the Ministry of Planning and Finance has so far assessed and collected tax on imported and exported goods at the weekly exchange rate based on the reference rate published daily by the Central Bank of Myanmar, but will switch to assessing and collecting tax at the weekly exchange rate based on the market trading rate instead of the reference rate.
- 3. This notification shall take effect from 1 January 2025.
